Sudan Liberation Movement/ Army Road map to a just and sustainable Peace in Sudan

The Sudan Liberation Movement/ Army renew its eternal commitment to political settlement that will allow all Sudanese to enjoy dividends of peace equally and respect the views of All political parties, SRF components and others on how to bring peace to Sudan; nevertheless, remain committed to its principle position of (conflict suspension first by the regime of Khartoum), accordingly the unilateral conducive environment that should be implemented by Khartoum regime before meaningful peace agreement take place are the followings:-

- 1- Civilians security first which means stopping of the ongoing genocide and wars in Dar Fur Nuba Mountain and the Blue Nile, through stopping the killing of civilians, halt of aerial bombardments, disarmament of Janjaweed militias and all regime paratroops such as Border Guards, Rapid Support Force (RSF).....etc and allowing unimpeded access of relief and humanitarian assistances to all war - affected areas of Sudan.
- 2- Remove of the new-comers from the lands and Hawakeers of the indigenous people (giving of the usurped lands to their rightful owners)

- 3- Return of the IDPs and refugees to their original lands, villages.....etc to resume their livelihood.
- 4- Individual and collective compensation the IDPs and refugees as well as all those affected by wars in Sudan.
- 5- Putting and an end to NCP's policies of inciting tribal conflicts among Arab tribes of Dar Fur
- 6- Taking the wanted war criminals to the ICC and establishing of national tribunal court to fairly trail all those who committed genocide, war crimes and crimes against humanity without any impunity.
- 7- Immediate release of all political detainees and prisoners of opinion and belief.
- 8- Abrogate of all laws that restrict public freedoms.
- 9- Abrogate gag laws and lift censorship on the media.
- 10- Allowing all political parties and civil society organizations to mobilize, hold rallies and exercise their activities freely

The above –mentioned steps are the confidence building measures then comes the next steps which are:-

- 11-Conflict resolution which means addressing the root causes to the conflicts in Sudan which include but not limited to wealth and power sharing, security arrangements, affirmative action, bill of rights.....etc.
- 12- Formation of transitional national government to undertake certain responsibilities such as, safeguarding and implementation of what is reached on phase (11), maintaining law and order and generally providing security to all Sudanese and ensure protection of civilians. This process should not be led by the National Congress Party (NCP), which used to dishonoring agreements and cannot be trusted by anybody or party, but they can be part of the process like any other political party of Sudan.
- 13- Conducting of Constitutional National Conference that will be attended by all representatives of Sudanese from different political walk of life , IDPs and Refugees, civil society organizations



representing all regions of Sudan, youth groups and students, women organizations, diaspora representatives, tribal leadersetc to tackle non exhaustive list of issues such as :-

- a. Religion and state
- b. Addressing the problem of the Sudanese national identity to allow managing of the blessing diversity and let Sudanese realize the potential of their existing cultural, religious, racial and geographical pluralism.
- c. Endorsement of the reached agreements
- d. Addressing human rights issues with special emphasis on gender balance and inclusivity
- e. Ensuring of the affirmative action
- f. System of good governance and transparency
- g. Reform of the foreign policy
- h. Drafting of a permanent constitution
- i. Enactment of new electoral law and drawing of constituencies
- j. Conducting of credible national census to be a guideline for even development and providing of services
- k. National security issues including maintaining of good neighbor lings relations and counter- terrorism
- l. Organization of free, fair, and internationally monitored election so that the Sudanese masses choice their leaders
- m. Plus others
